1. The Board headed by the Station Officer, Fire and Rescue station, PATHANAMTHITTA has inspected the above said building and recommended to renew the No objection Certificate.

3. This certificate is issued on the condition that the fire fighting system installed will be kept always functional and the owner of the building should take special care to maintain the systems installed in proper working condition in all time. **This certificate is valid for 5 years from the date of issue. After 5 years the certificate must be renewed. Non renewal of the certificate within the time limit will result in the loss of eligibility for insurance coverage and appropriate legal action by the Local Self Government/Revenue Department.** All Officers of and above the rank of Station Officers of the Fire & Rescue Services Department will have the right to inspect the building on any day/time after serving 7 days notice to ensure that the installed systems are in good working condition.
